CASH MANAGEMENT PLAN OF THE BOROUGH OF STANHOPE, NEW JERSEY

I. STATEMENT OF PURPOSE

This Cash Management Plan (the õPlanö) is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits (õDepositsö) and investment (õPermitted Investmentsö) of certain Public funds of the Borough of Stanhope (the Borough) pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to insure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to insure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments. All investments shall be made on a competitive basis insofar as practicable.

II. IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN

- A. The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Borough:
 - Current Fund
 - Water Operating Fund
 - Sewer Operating Fund
 - Capital Fund
 - Water Capital Fund
 - Sewer Capital Fund
 - POAA Funds
 - Animal Trust Fund

 - Other Escrow Trust
 - Public Defender Trust Fund
 - Other Trust Fund
 - Recycle Trust Fund
 - SUI Trust Fund
 - Payroll Trust Fund
 - Any other accounts within the Boroughøs name and any of its agencies

III. <u>DESIGNATION OF OFFICIALS OF THE COUNTY AUTHORIZED TO MAKE</u> <u>DEPOSITS AND INVESTMENTS UNDER THE PLAN</u>

The Chief Financial Officer of the Borough the õDesignated Officialö is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan and shall thereafter be relieved of any liability for loss of such moneys due to insolvency or closing of any depository designated by, or the decrease in value of any investment authorized, by the Cash Management Plan. Prior to making any such Deposits or any Permitted Investments, such official of the Borough is directed to supply to all depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file with such official.

IV. DESIGNATION OF DEPOSITORIES.

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of Deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

All such depositories shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official referred to in Section III above.

V. <u>DESIGNATION OF BROKERAGE FIRMS AND DEALERS WITH WHOM THE DESIGNATED OFFICIALS MAY DEAL</u>

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official of the Borough referred to in this Plan may deal for purposes of buying and selling securities identified in this Plan as Permitted Investments or otherwise providing for Deposits. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official referred to in Section III above.

VI. AUTHORIZED INVESTMENTS

- A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:
 - (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
 - (2) Government money market mutual funds;
 - (3) Any obligation that a federal agency or federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
 - (4) Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located:
 - (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units;
 - (6) Local government investment pools;
 - (7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281 (C.52:18A-90.4); or
 - (8) Agreements for the repurchase of fully collateralized securities if:
 - (a) the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection a;
 - (b) the custody of collateral is transferred to a third party;
 - (c) the maturity of the agreement is not more than 30 days;
 - (d) the underlying securities are purchased through a public depository as defined in section 1 of P.L. 1970, c.236 (C.17:9-41); and
 - (e) a master repurchase agreement providing for the custody and security of collateral is executed.
- B. Any investments not purchased and redeemed directly from the issuer, government money market mutual fund, local government investment pool, or the State of New Jersey Cash Management Fund, shall be purchased and redeemed through the use of a national or State bank located within this State or other financial intermediary through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1997, c.93 (C.49:3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and

reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

For purposes of the above language, the terms õgovernment money market mutual fundö and õlocal government investment poolö shall have the following definitions:

Government Money Market Mutual Fund. An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the õInvestment Company Act of 1940,ö 15 U.S.C. sec. 80a-1 et seq., and operated in accordance with 17 C.F.R. sec. 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec.270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; in which direct investment may be made pursuant to paragraphs (1) and (3) of subsection (a) of this section and

(c) which has:

- (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
- (ii) retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the õInvestment Advisors Act of 1940ö, 5 U.S.C. sec.80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.
- (d) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value.

<u>Local Government Investment Pool</u>. An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270.2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities. Same as Money Market;
- (d) which is in compliance with rules adopted pursuant to the õAdministrative Procedure Act,ö P.L. 1968, c.410 (c.52:14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (C.49:3-56) and

has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

Any official involved in the designation of depositories or in the authorization for investments as permitted pursuant to section 8 of P.L. 1977, c.396 (C.40A:5-15.1), or any combination of the preceding, or the selection of an entity seeking to sell an investment to the local unit who has a material business or personal relationship with that organization shall disclose that relationship to the governing body of the local unit and to the Local Finance Board or a county or municipal ethics board, as appropriate.

VII. <u>SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGMENT OF RECEIPT OF PLAN</u>

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Borough, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Borough of Stanhope to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a õdelivery versus paymentö method to insure that such Permitted Investments are either received by the Borough or by a third party custodian prior to or upon the release of the Boroughos funds.

To assure that all parties with whom the Borough deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official.

VIII. REPORTING REQUIREMENTS

On the first day of each month during which this Plan is in effect, the Designated Official(s) referred to in Section III hereof shall supply to the governing body of the Borough a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

A. The name of any institution holding funds of the Borough as Deposit or Permitted Investment.

VIII. <u>REPORTING REQUIREMENTS</u> (Continued)

- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased or Deposits made.
- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the Borough.

IX. TERM OF PLAN

This Plan shall be in effect from January 1, 2012 to December 31, 2012. Attached to this Plan is a resolution of the governing body of the Borough approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Borough, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

Mayor Maio invited all appointees to Boards and Commissions who were present to come forward and have their oaths of office administered by Borough Attorney, Richard Stein.

Mayor's Highlights of 2011

Mayor Maio invited outgoing Mayor Diana Kuncken to speak of the highlights of 2011. Diana Kuncken reported that last year at this time we had all spent the previous week digging out after the big snowstorm on December 26th. It was only the beginning of what would turn out to be a long, cold, snowy, icy ó never seem to quit ó winter. It depleted our salt reserves, exhausted our DPW and took its toll on our snow removal equipment. Little did we know how much a player Mother Nature was going to be in 2011. She would turn out to be the wild card!

In the first quarter of the year we began our search for an Administrator. We received numerous resumes, conducted interviews and when the process was completed the governing body hired Brian McNeilly as the new Administrator.

Following the Spring rains, we were able to complete the High Street & Plane Street Project, the Sparta Road Water Main Replacement Project and the repair of Reservoir #2.

The long awaited purchase of the municipal building generator and the crack sealing machine became a reality.

During the course of the year we changed our electric provider and the phone system. As a result of the Energy Audit Grant we replaced lighting in the municipal building, replaced a furnace in the DPW garage and in the storage building and added some insulation. The final piece came later in the year when all of the windows in the municipal building and the police department were replaced. We are hoping to see a savings in energy costs as a result of these changes.

Just like every other municipality in 2011 we faced the new 2% budget cap. I am proud to say that with good prior fiscal planning and a realistic approach to both revenues and expenses we adopted a budget within the 2% cap with no exceptions. We negotiated new contracts with both the PBA and the DPW and I would like to express my thanks to both bargaining units for their cooperation and understanding.

With the retirement of Court Administrator, Lorraine Lupo, and knowing that the physical layout of our Court Room would no longer meet current requirements, we negotiated an agreement with Hopatcong for a shared court.

On the 10th anniversary of the September 11th attack we had a re-dedication ceremony at our 9/11 Memorial and we especially recognized Stanhope resident Joseph Vilardo.

Back to the wild card ó Mother Nature ó after a scorching July came rains in August, the earthquake and Hurricane Irene. When we had barely recovered from that came the õmacro burstö which sent incredible amounts of water, the likes of which we had never seen, into and out of all kinds of places. And then to add insult to injury came the October 29th blizzard ó piling up snow, knocking down trees and wires and plunging us into 4-6 days without power. As they say, õnever underestimate the power of nature.ö It was an experience that took a great toll on our residents and the Borough. Much of the responsibility for clean-up fell to the DPW and they worked for weeks trying to get things cleaned up. I am told that last Thursday the last of the leaves were picked up and rumor has it that even the Administrator was on leaf patrol.

We said a sad good-bye to Margaret Driscoll who retired after 25 years of service. Margaret wore several hats during her career and we love, respect her and will miss her. She was affectionately known as õthe crabö and her office was decorated with several of the creatures. A sign hung outside her door that õThe Crab Is In.ö On her last day she left a note behind which said õThe crab is gone and she will miss you.ö Thatøs our Margaret.

On the day before Thanksgiving our little Borough family was rocked to its core by the news that Officer Joe Johnsonøs little boy had a brain tumor and would undergo surgery. Suddenly, all that mattered to any one of us was little Joey and we monitor his progress on virtually a daily basis. I hope that whatever your beliefs are that you join us in hoping and praying for Joey and the Johnson family. A fund has been established in Joeyøs name and if you would like information about donating you can speak to our Police Department or the Borough office.

It has been my honor and pleasure to serve as the Mayor of Stanhope for the past 8 years and I thank the people of our community for that opportunity. I have met and worked with many good people over the years and I am grateful to all of them.
