CASH MANAGEMENT PLAN OF THE BOROUGH OF STANHOPE, NEW JERSEY

I. STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan") is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain Public funds of the Borough of Stanhope (the Borough) pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to insure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to insure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments. All investments shall be made on a competitive basis insofar as practicable.

II. <u>IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN</u>

- A. The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Borough:
 - Current Fund
 - Water Operating Fund
 - Sewer Operating Fund
 - Capital Fund
 - Water Capital Fund
 - Sewer Capital Fund

- POAA Funds
- Animal Trust Fund
- Developer's Escrow Trust
- Other Escrow Trust
- Public Defender Trust Fund
- Other Trust Fund
- Recycle Trust Fund
- SUI Trust Fund
- Payroll Trust Fund
- Any other accounts within the Borough's name and any of its agencies

III. <u>DESIGNATION OF OFFICIALS OF THE COUNTY AUTHORIZED TO MAKE</u> <u>DEPOSITS AND INVESTMENTS UNDER THE PLAN</u>

The Chief Financial Officer of the Borough the "Designated Official" is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan and shall thereafter be relieved of any liability for loss of such moneys due to insolvency or closing of any depository designated by, or the decrease in value of any investment authorized, by the Cash Management Plan. Prior to making any such Deposits or any Permitted Investments, such official of the Borough is directed to supply to all depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file with such official.

IV. DESIGNATION OF DEPOSITORIES.

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of Deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

All such depositories shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official referred to in Section III above.

V. <u>DESIGNATION OF BROKERAGE FIRMS AND DEALERS WITH WHOM THE</u> <u>DESIGNATED OFFICIALS MAY DEAL</u>

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official of the Borough referred to in this Plan may deal for purposes of buying and selling securities identified in this Plan as Permitted Investments or otherwise providing for Deposits. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official referred to in Section III above.

VI. <u>AUTHORIZED INVESTMENTS</u>

- A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:
 - (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
 - (2) Government money market mutual funds;
 - (3) Any obligation that a federal agency or federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
 - (4) Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
 - (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units;
 - (6) Local government investment pools;
 - (7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281 (C.52:18A-90.4); or
 - (8) Agreements for the repurchase of fully collateralized securities if:
 - (a) the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection a;
 - (b) the custody of collateral is transferred to a third party;
 - (c) the maturity of the agreement is not more than 30 days;
 - (d) the underlying securities are purchased through a public depository as defined in section 1 of P.L. 1970, c.236 (C.17:9-41); and
 - (e) a master repurchase agreement providing for the custody and security of collateral is executed.
- B. Any investments not purchased and redeemed directly from the issuer, government money market mutual fund, local government investment pool, or the State of New Jersey Cash Management Fund, shall be purchased and redeemed through the use of a national or State bank located within this State or other financial intermediary through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1997, c.93 (C.49:3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund. An investment company or investment trust:

(a) which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940," 15 U.S.C. sec. 80a-1 et seq., and operated in accordance with 17 C.F.R. sec. 270.2a-7.

- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec.270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; in which direct investment may be made pursuant to paragraphs (1) and (3) of subsection (a) of this section and
- (c) which has:
 - (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
 - (ii) retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940", 5 U.S.C. sec.80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.
- (d) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value.

Local Government Investment Pool. An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270.2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities. Same as Money Market;
- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, c.410 (c.52:14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (C.49:3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

Any official involved in the designation of depositories or in the authorization for investments as permitted pursuant to section 8 of P.L. 1977, c.396 (C.40A:5-15.1), or any combination of the preceding, or the selection of an entity seeking to sell an investment to the local unit who has a material business or personal relationship with that organization shall disclose that relationship to the governing body of the local unit and to the Local Finance Board or a county or municipal ethics board, as appropriate.

VII. <u>SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGMENT OF</u> <u>RECEIPT OF PLAN</u>

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Borough, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Borough of Stanhope to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to insure that such Permitted Investments are either received by the Borough or by a third party custodian prior to or upon the release of the Borough's funds.

To assure that all parties with whom the Borough deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official.

VIII. <u>REPORTING REQUIREMENTS</u>

On the first day of each month during which this Plan is in effect, the Designated Official(s) referred to in Section III hereof shall supply to the governing body of the Borough a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

A. The name of any institution holding funds of the Borough as Deposit or Permitted Investment.

VIII. <u>**REPORTING REQUIREMENTS**</u> (Continued)

- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased or Deposits made.
- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the Borough.

IX. <u>TERM OF PLAN</u>

This Plan shall be in effect from January 1, 2013 to December 31, 2013. Attached to this Plan is a resolution of the governing body of the Borough approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Borough, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

OATHS OF OFFICE

Mayor Maio invited incoming Fire Chief Gary Card and other officers for the Stanhope Hose Company No. 1 to step forward to be sworn in. Richard Stein, Borough Attorney, administered the Oath of Office to the officers of the Stanhope Hose Company No. 1.

Mayor Maio invited all appointees to Boards and Commissions who were present to come forward and have their oaths of office administered by Borough Attorney, Richard Stein.

AWARDS AND RECOGNITION

Police Department Awards

Chief Steve Pittigher came forward and announced he had two citations to present. Chief Pittigher stated Sergeant Ryan Hickman and Officer Robert Popelka responded to a call on October 2, 2012 for an unresponsive woman. The officers used life-saving methods and revived the woman before she was transported to the hospital. The woman spent several weeks in the hospital, was released and is alive and well today. Chief Pittigher praised the efforts of both officers.

Chief Pittigher asked Officer Robert Popelka to come forward and presented him with the "Life Saving Award."

Chief Pittigher advised that due to illness, Sergeant Hickman was unable to be present.

The Mayor offered congratulations from her and the Council to Officer Popelka and Sergeant Hickman and praised the efforts of all the Stanhope Police Officers.

MAYOR'S HIGHLIGHTS OF 2012

Mayor Maio stated that while we have all been admonished at one time or another not to wish time away, thanks to Super Storm Sandy I can honestly say I'm glad the year is over.

It was a horrific time for all of us, but a time when the best of our human nature rose to the surface. Neighbors shared the warmth of their generators, their meals, their homes and their company with each other. Volunteers and Borough employees did an outstanding job of keeping our residents safe and as comfortable as could be, given circumstances most of us had never before experienced. And while we suffered as a community with the total destruction of three homes, partial damage to a number of others, the loss of dozens of cars and an as yet uncounted number of beautiful old trees, we can be thankful that we suffered no serious injuries anywhere in the Borough.

Sandy was the Borough's bad news for 2012. The good news is that we accomplished a great deal, finished up a number of projects that had been planned or started in previous years and took a giant leap forward on some exciting new programs.

We completed the replacement of new water mains and pipes along Sparta Road.

The upgraded chlorination system for our wells was completed and we now treat all of our wells with a much safer system utilizing chlorine tablets rather than gas.

We introduced an ACH debit program which allows those residents, who so choose, to pay their property taxes and/or water and sewer bills through automatic withdrawal from their savings or checking accounts. It is no less painful, but certainly more convenient.

We milled and paved Church Street and Linden Avenue and oiled and chipped 10 additional roads, some of which we had planned to repair in 2011 but were delayed due to Hurricane Irene and the October snowstorm.

We entered into a shared services agreement with Sussex County to utilize the County's Fire Marshal for fire inspections, a move that cost us nothing and which we believe will improve fire safety among our commercial properties.

We underwent a Borough-wide property reassessment to ensure that residential and commercial properties were fairly assessed according to current property values.

We established Smoke Free Zones in our parks and on all Borough-owned properties.

We contracted the services of Millennium Strategies for grant writing and with their help, and that of our Borough Engineer, we applied for three major grants, including one to extend sidewalks along Route 183 into Byram and another for long overdue road and water line improvements on the lower end of Maple Terrace.

Through the efforts of our Recreation Department, we joined with Netcong and Byram in an expanded Summer Camp program for Borough youngsters.

We acquired the property adjacent to the Municipal Building and will determine this year whether to sell it for commercial development or maintain it for future use by the Borough.

Working with Fire Chief Card and the members of the Fire Department, we investigated options for updating our fire emergency notification system and we decided to purchase high band radio equipment for the department. We are awaiting the approval of our FCC license and expect to be able to retire our 1950's air raid sirens and replace them with modern, up to date equipment this year.

We completed our first full year of a shared court with the Borough of Hopatcong. This move has saved us a bit of money and allowed us to provide the Police Department with better security, much needed additional space and a major – and much-needed - face-lift.

Utilizing funds which were allocated as far back as 2001, we have begun a renovation project at the Municipal Building beginning with renovations to the Council chambers, a project which will continue through 2013, to provide more efficient use of our available office space and a much more welcoming environment for both residents and employees.

We proudly joined with the Borough of Netcong in providing funds for the Stanhope-Netcong American Legion Ambulance Corps to purchase a new ambulance to be delivered sometime this spring. The new ambulance will replace a 13-year old rig and enable our dedicated volunteers on the squad to continue to provide outstanding service to the members of our two communities.

And, finally, we have begun the long-anticipated upgrading of our Borough-wide water system, a multiyear project which will be funded through a low-cost loan from the New Jersey Environmental Infrastructure Trust.

This project, which will cost more than two million dollars, will be repaid from existing water utility fees and be accomplished at no additional cost to our residents and business owners. We have talked for many years about this project – and the critical need it represents in not only maintaining the delivery of water throughout the Borough but also in improving water pressure to many homes and insuring that sufficient pressure is available to safely fight fires.

The project will be done in phases and will include repairs and upgrades to our existing water tank and the repair and replacement of pipes, valves, and water mains throughout the Borough. The time and opportunity were right and the Governing Body has taken a giant leap forward in ensuring that this critical service will be in good working order for many years to come.

And so, despite the devastation of Super Storm Sandy, 2012 was a pretty good year in the Borough. Much was accomplished. Many projects were completed and many more were begun. The bar has been set pretty high for 2013 and the members of your Governing Body have never been more dedicated to doing whatever it takes to maintain our quality of life here and to do so in an efficient and fiscally responsible manner.

We thank our employees, our professional staff, and our volunteers for their on-going efforts and contributions and we encourage all of you to continue to challenge us and to work with us to keep Stanhope a community in which we can all be proud. Thank you.
