PROCLAMATION

Mayor Maio noted Dave Hoyt will be retiring from over 30 years of service as the Borough's representative to the Musconetcong Sewerage Authority. Mayor Maio read the following Proclamation:

WHEREAS, *Dave Hoyt* has proudly served as a Commissioner on the Musconetcong Sewerage Authority as the Borough's representative since 1977; and

WHEREAS, during his tenure, *Dave* served numerous years as Chairman and Vice-Chairman of the Musconetcong Sewerage Authority; and

WHEREAS, the Musconetcong Sewerage Authority is an advanced wastewater treatment facility servicing the Borough of Stanhope as well as Byram Township, Hopatcong Borough, Mt. Arlington Borough, Mt. Olive Township, Netcong Borough and Roxbury Township; and

WHEREAS, *Dave* contributed to the efforts to replace the original Sewerage Treatment Plant in order to and allow for expansion of the service area, and be in compliance with new permitting regulations and requirements; and

WHEREAS, as an active Commissioner, *Dave* always kept the future needs of our town in his vision, bringing his knowledge and understanding of the Borough's needs to the operations within the Musconetcong Sewerage Authority; and

WHEREAS, *Dave* contributed his time, energy and abilities participating in the efforts to create a state-of-the-art wastewater treatment facility servicing our community; and

WHEREAS, *Dave's* life of dedicated service to our community has earned him the acknowledgment, appreciation and gratitude of the Mayor and Council and citizens of our community;

WORK SESSION

<u>2014 Municipal Budget</u> – Mayor Maio scheduled a Special Budget Meeting to be held on Wednesday, January 22, 2014 at 7:00 p.m.

<u>Water Tower</u> – Mayor Maio noted the bid received for the project was \$164,000 over the estimate. The governing body must discuss whether or not they are going to accept the bid and the funding impact. Dana Mooney, CFO came forward. Ms. Mooney stated the Borough is funding two separate projects for a total of \$2.3 Million Dollars funded through Ordinance 2012-18. Ms. Mooney provided a breakdown of the hard costs provided by the engineer, the actual bid amount, computed loan amount which includes hard and soft costs, the total loan allowed and the amount the Borough must finance. Ms. Mooney stated the water tank bid was over by \$164,760; however there is a 5% contingency built in so the difference may be less by approximately \$20,000. Once the loan is received, the amount the Borough must fund is \$164,000. This is money included in the ordinance that the governing body agreed to bond for. The difference of the \$164,000 will be paid back at the market rate at the time versus 1.8%. There is a minimal increase in the amount the Borough will be paying. Ms. Mooney recommended the governing body accept the bid and award the contract.

Ray Sarinelli, Borough Auditor, came forward. Ms. Sarinelli agreed with Ms. Mooney's calculations and recommendation. The Borough has the full authorization for the \$2.3 Million Dollars and all funding is in place to proceed with the project.

Mayor Maio asked for Council comments or questions. Councilman Thornton questioned rejecting the bid. Councilwoman Kuncken stated if the bid was rejected, that portion would not be included in the NJEIT funding. The Borough would be responsible for the entire amount. Mayor Maio polled Council on if they should accept the bid. Councilman Depew – yes; Councilman Benson – yes; Councilman Thornton – yes; Councilwoman Zdichocki – yes; Councilwoman Thistleton – yes; Councilwoman Kuncken – yes.

Lee Purcell, Water Project Engineer, came forward. Mr. Purcell recommended awarding the contract. Mr. Purcell explained the reason only one bid was received. Due to the need to comply with the tight time schedule of the NJEIT funding program, bids were received on January 3, 2014 despite the severe snow storm the evening prior to the bid opening. Several bidders indicated to him that the severe weather conditions prevented them from bidding. There were also bids being received in other parts of New Jersey for the same type of project on the same or close to the same day on which the Borough was receiving bids. Mr. Purcell said his firm spoke to a majority of potential bidders after the bid opening and they indicated that they were concentrating their bid preparation efforts on the larger and possibly more lucrative projects. Mr. Purcell stated the governing body must award the contract by February 1st and, therefore, it is not possible for the Borough to go out to bid again. Mr. Purcell recommended awarding the contract to the contractor who submitted the only bid. Mr. Purcell stated he does not anticipate any change orders for this project. Councilwoman Kuncken spoke of the need to carefully monitor the costs and to keep moving through the process on budget since the NJEIT does not permit the transfer of funds from one project to the other project. Mr. Purcell assured the governing body that he will carefully monitor the project.

ADMINISTRATOR'S REPORT

Administrator McNeilly had no written report.

Mayor Maio asked for an update on the various water main breaks that recently occurred. Administrator McNeilly responded there have been a number of water main breaks, service leaks and service connection breaks that are being addressed. Administrator McNeilly spoke about the issue on Reeve Avenue. The cost to replace the entire line would be over \$10,000. Administrator McNeilly said he hesitates to have the property owner expend such a large sum of money when in less than six months the water main will be passing through the property as part

of the Borough's water main replacement project. Administrator McNeilly will continue to monitor the situation.

COUNCIL DISCUSSION

<u>DPW Yard</u> - Councilman Depew stated that while at the DPW yard, Gary Stevens informed him that he is finding items in the dumpster that should not be there. Councilman Depew questioned why the gate is left open when there are no employees present at the yard. Administrator McNeilly will reiterate to the DPW Superintendent that the gate must be locked when no employee is present at the site.

WHEREAS, after careful consideration, the Governing Body has found it to be in the best interests of the Borough to award Contract #WST-2-12 to Alpine Painting & Sandblasting;
