Mayor Maio opened the meeting to the public after advising attendees that there is a five (5) minute time limit for each speaker.

Seeing no one from the public wishing to speak, Mayor Maio closed the public portion of the meeting.

#### ADMINISTRATOR'S REPORT

<u>Municipal Infrastructure</u> – Administrator McNeilly stated the Spring Street water main has been installed and is in use. The Hillside Avenue water main is scheduled to be done next.

<u>Public Safety</u> – Administrator McNeilly reported the Fire Department has received the air packs which were obtained with the grant.

<u>Technology</u> – Administrator McNeilly stated he and Mr. Stein are working on amendments to the service agreement for the website.

<u>Borough Sign (South End of Main Street)</u> – Administrator McNeilly stated the final changes requested by the Mayor and Council have been sent to Sign Art. Once the changes are confirmed a Purchase Order will be submitted. A quote has been requested specifically for the business plaques. This information, along with the sample Borough sign, will be provided to the sub-committee for the Chamber of Commerce when available. Mayor Maio stated she will be meeting with the Chamber of Commerce tomorrow morning.

<u>Houdaille Road / Plane Street Bridge</u> – Administrator McNeilly stated the NJ DEP has been reviewing the bridge site to determine for required permits. At last report, they have concluded that all site prep will fall under permit-by-rule. Land Management in Trenton has some concerns over the actual ownership of the right of way. Administrator McNeilly has forwarded copies of the tax maps. Administrator McNeilly stated final written confirmation must be received prior to work beginning on the Stanhope side of the river.

<u>Reclamation Project</u> – Administrator McNeilly reported that a memo was sent to the Governing Body indicating there were no bidders for this project. The reclamation project includes Spring Street, Coursen Street, Port Morris Avenue and Hillside Avenue. Administrator McNeilly stated he and Eric Keller, Borough Engineer, have revised the specifications for the reclamation project in an attempt to get active bidders. There is a resolution authorizing to go to bid on the agenda this evening. The timeline is as follows:

Bid Opening: August 20, 2015
Bid Award: August 25, 2015

Bid Award: August 25, 2015 Work Should Begin on the 3<sup>rd</sup> or 4<sup>th</sup> Week of September <u>James Street</u> – Administrator McNeilly stated the work on James Street is progressing according to plan. The drainage work is complete and the curbing is more than 50% complete.

<u>Crack Sealing</u> – Administrator McNeilly stated crack sealing will be done on Grove Road, Elm Street and Delaware Avenue.

<u>Letter to Property Owners</u> – Administrator McNeilly stated a letter will be sent this week to the property owners on Lloyd Avenue, Lawrence Avenue, Reeve Avenue and Maple Terrace regarding the timeframe for the milling and paving work to be done. Mayor Maio asked if the date has been confirmed with Tilcon. Administrator McNeilly stated the confirmed date is August 10<sup>th</sup>. There is a two week window to account for weather and milling. The work should be completed by August 21<sup>st</sup>.

<u>2016 Budget</u> – Administrator McNeilly stated the budget/capital letter will be sent out tomorrow with a return date of August 28<sup>th</sup>.

<u>Water Pressure (Towpath Lane)</u> - Mayor Maio asked Administrator McNeilly if any additional information is available regarding the water pressure issue on Towpath Lane. Administrator McNeilly stated he has informed the property owners that the pressure test will be done as soon as the water project is complete.

<u>Finance</u> – Mayor Maio stated a tax sale memo was sent out by the CFO on July 6<sup>th</sup> regarding the tax sale. Mayor Maio asked why the names on the tax sale list are not removed once payment has been received. Mayor Maio stated in other counties the lists are revised as payment is received. Revising the list would reduce the size of the advertisement and lower the cost of the advertisement. Administrator McNeilly stated he will ask for clarification from the CFO.

<u>Payroll 2016</u> - Councilman Romano stated the CFO distributed a memo regarding a payroll for next year. Councilman Romano is of the opinion the pay schedule should be adjusted based on the salaries for the year. Administrator McNeilly stated the CFO should speak with the Mayor and Council and/or the Finance Committee regarding this issue. Mayor Maio stated this payroll issue occurs every few years and she is of the opinion that the entire payroll process should not have to be changed. Mayor Maio stated a Finance Committee meeting should be scheduled.

# **COUNCIL DISCUSSION**

<u>Municipay</u> – Mayor Maio asked if any additional information is available. Councilman Romano stated the CFO is still waiting for a reply from Municipay regarding Mr. Stein's concerns.

<u>Crosswalk Rehabilitation</u> — Mayor Maio stated she, Administrator McNeilly, Councilman Thornton and Councilwoman Kuncken met with the company that supplies the Endurablend crosswalk material and with the company, Traffic Patterns, who supplies the Thermoplastic product. The committee was not impressed with the Endurablend product or the presentation. The recommendation is to move forward with the Traffic Patterns group. Administrator McNeilly stated both products require the surface to be milled out and blacktopped. Administrator McNeilly described the process for installing the product from Traffic Patterns. Mayor Maio stated the product can be repaired in the future if necessary. Mayor Maio stated the crosswalks will have to be redone every five to six years regardless of which product is used. The cost of the two products is almost identical.

Councilman Depew asked if there is a warranty. Administrator McNeilly stated due to the cost the Borough will have to go out to bid. There would be a one year performance bond and a one year maintenance bond as a result of the bidding. Much discussion took place regarding the product. Mayor Maio stated based on the committees report the recommendation is to go with the Traffic Patterns material. The crosswalk project would be placed in the budget for next year. Councilman Thornton stated the estimate is approximately \$40,000 which includes the preparation work. A separate company would be contracted to do the preparation work and then the certified installers would install the crosswalks.

<u>Resolution Supporting Establishment of U.S. Dept. of Veterans Affairs Outpatient Clinic in Sussex County</u> – Mayor Maio stated the Borough of Franklin has sent a copy of their resolution supporting the establishment of a veteran's outpatient clinic in Sussex County. Mayor Maio stated Franklin has the location available in their municipality to establish the clinic. Most counties have outpatient clinics, but Sussex County does not. Mayor Maio is of the opinion that Stanhope Borough should support the establishment of the clinic. Mayor Maio asked the Governing Body if there were any comments or objections. Seeing none, Mayor Maio asked Administrator McNeilly to contact Mr. Stein to draft the resolution.

<u>Lakeview Estates Block Party Request</u> – Mayor Maio stated Lakeview Estates has sent a letter requesting permission to hold their annual block party on Towpath Lane. The block party has been held every year since this development was established. The road would be closed on September 19<sup>th</sup> from 11:00AM to 8:00PM, between house numbers 10 and 14. The Governing Body approved the request. The resolution will be added to the next meeting agenda.

<u>Property Maintenance (Owner Occupied)</u> – Mayor Maio stated she has been receiving multiple complaints from residents regarding properties that are not being maintained, despite the fact that the homes are owner occupied. There are homes on Lloyd Avenue, Delaware Avenue and Kelly Place. The Stanhope Borough code book does not address owner occupied residences with regard to property maintenance. The only item that is enforceable is grass overgrowth. Mayor Maio stated there are provisions for enforcing maintenance on commercial and rental properties but not owner occupied property.

Administrator McNeilly stated the Borough's property maintenance code was adopted twenty five years ago and it makes a distinction between owner occupied and not owner occupied. Mayor Maio stated residents are concerned about health issues and property values. Administrator McNeilly gave an overview of the current code. Mayor Maio stated she is of the opinion that the same code for commercial properties should not apply to residential properties. Mayor Maio asked Administrator McNeilly to obtain copies of code from other municipalities in Sussex County for comparison. This item will be placed back on the agenda for ongoing discussion. Mayor Maio stated the Borough is not looking to be so restrictive that residents cannot decorate or paint in the way they want. The code would be put in place for basic maintenance. Administrator McNeilly stated he will collect copies of code from various municipalities and he suggested the Governing Body review the Borough's current code which is Chapter 111.

# Ordinance 2015-15 AN ORDINANCE AMENDING ORDINANCE 2015-12 TO AMEND THE DEFINITION OF THE TERM "OWNER"

**BE IT ORDAINED,** by the Mayor and Council of the Borough of Stanhope, Sussex County, New Jersey, as follows:

#### **SECTION 1**

Ordinance 2015-12 finally adopted on July 14, 2015 is hereby amended as follows:

The definition of the word "owner" as contained in Article 1 - Section 1 - Definitions of Ordinance 2015-12 is hereby amended to read as follows:

## **OWNER-**

Shall include the title holder, any agent of the title holder having authority to act with respect to a vacant property, any foreclosing entity subject to the provisions of

C.46:10B-51 (P.L. 2008, c. 127, § 17), or any other entity determined by the Borough of Stanhope to act with respect to the property. The term "Owner" shall not include any duly licensed real estate agent engaged solely in the sale of the property on behalf of the Owner.

## **SECTION 2 - When Effective**

This ordinance shall take effect immediately upon final passage and publication as required by law.
