#### CALL TO ORDER

#### MAYOR'S STATEMENT AS TO COMPLIANCE WITH P.L. 1975

#### SALUTE TO COLORS

Mayor Maio invited all those present to stand in a salute to colors.

#### ADMINISTRATOR'S REPORT

Administrator McNeilly noted his report as presented.

<u>Hopatcong Court</u> – Administrator McNeilly reported that Hopatcong Court has decided to accept credit card payments for court fines. There will be a resolution on the next meeting agenda supporting this action. There will be no additional fees charged to the Borough of Stanhope. Mayor Maio questioned why Hopatcong is not passing the credit card fee onto the person receiving the fine and she asked for confirmation that none of the fees will be passed onto the Borough of Stanhope in the future. Administrator McNeilly will contact Hopatcong and clarify that there will be no additional money charged to Stanhope for credit card payments.

<u>Crack Sealing</u> – Councilman Murphy stated when a contractor for Sussex County was crack sealing County Road 606, they put down coal slag which keeps the sealer from becoming slippery when wet. Cars can travel over the road soon after and do not pick up the tar. Councilman Murphy noted this is not done when the DPW crack seal Borough roads. Administrator McNeilly stated that, when crack sealing, the DPW follows the State's procedure. The DPW has compressed air set up on the front of the truck. One worker blows the crack out, another worker then fills the crack and then they take measures to prevent it from being taken up by vehicles traveling over the road. He will speak to Bill Storms about the County's contractor's procedure.

#### COUNCIL DISCUSSION

<u>Lakeview Estates Block Party Request</u> – Mayor Maio noted the Borough received a request from Lakeview Estates to close off the street to hold their annual block party. Council agreed to grant the request.

<u>Water System Improvements</u> – Mayor Maio stated that the intention was to have a Finance Committee meeting this morning to discuss this matter and to have Ray Sarinelli attend this meeting. Ray Sarinelli is on vacation this week and Councilman Benson and Councilwoman Kuncken were unable to attend the meeting. Therefore, this subject will be discussed at the August 28, 2012 meeting, at which Ray Sarinelli will be present.

#### NEW BUSINESS

Ordinance for Introduction [Public Hearing on August 28, 2012]

Mayor Maio offered the following ordinance for introduction:

# Ordinance 2012-17AN ORDINANCE TO AMEND AND SUPPLEMENT<br/>CHAPTER 82 OF THE CODE OF THE BOROUGH OF<br/>STANHOPE ENTITLED "FEES" BY PROVIDING FOR A<br/>NEW SECTION TO ALLOW DEBIT PAYMENTS FOR<br/>TAXES AND UTILITY CHARGES

**BE IT ORDAINED** by the Mayor and Council of the Borough of Stanhope, Sussex County, New Jersey, as follows:

**SECTION 1**. Chapter 82 of the Code of the Borough of Stanhope is hereby amended to add a new subsection to read as follows:

#### Section 82-7 "ACH Debiting of Property Taxes and Utility Charges"

Any person wishing to pay municipal taxes and/or utility charges by debiting a bank checking or savings account shall provide the necessary information to the Tax Collector to establish the direct debit payment of property taxes and/or water and sewer payments on such form as shall be provided by the Tax Collector and shall pay an annual fee of \$5.00 for direct debit payment of property taxes and/or an annual fee of \$5.00 for direct debit payment of water and sewer charges.

**SECTION 2**. When effective. This ordinance shall take effect upon passage and publication, as required by law.
