COUNCIL DISCUSSION – Open House: Water System Improvement Project

Mayor Maio stated that tonight's meeting is an open house forum to discuss the Water System Improvement Project. This is the largest project that the Borough has undertaken since the sewers were installed many years ago. Mayor Maio stated that Mr. Lee Purcell and Mr. John Black, representatives from Purcell Engineering, are here this evening to answer any questions. Members of the Governing Body are also present to provide residents with information regarding the project. Several maps providing details of the project were on display. Printed handouts were also available.

Mayor Maio opened the meeting to the public. A member of the audience asked if the taxes will be increased. Mayor Maio replied that the taxes will not be raised. Mayor Maio stated that for the last several quarters the Borough reconfigured the water and sewer bills. The fixed rate for the sewer side of the bill was reduced and the rate for the water side was increased by the same amount. This has allowed the amounts billed for the water and sewer payments to remain the same and will provide the funds necessary for repayment of the loan. Mayor Maio stated unless there is some egregious problem, there will be no increase in taxes as a result of this project. Those in attendance were asked to sign the sign in sheet and meet with the representatives to have their questions answered.

This was the first Special Meeting regarding the Water System Improvement Project. Approximately 60 residents attended this meeting.
