At the conclusion of the Closed Session, Mayor and Council reconvened the public meeting at 8:00 P.M. with all present.

SALUTE TO COLORS

Council President Kuncken invited all those present to stand in a salute to colors.

CITIZENS TO BE HEARD

Council President Kuncken opened the meeting to the public after advising attendees that there is a five (5) minute time limit for each speaker.

Seeing no one from the public wishing to speak, Council President Kuncken closed the public portion of the meeting.

MINUTES FOR APPROVAL

Council President Kuncken read aloud the list of minutes being presented for approval:

July 9, 2013 Closed Session

July 23, 2013 Regular Business Meeting & Closed Session

On motion by Councilwoman Thistleton, seconded by Councilman Benson and unanimously carried by voice vote, the above listed minutes were approved.

CORRESPONDENCE (List Attached)

On motion by Councilwoman Thistleton, seconded by Councilman Benson and unanimously carried by voice vote, the list of correspondence was accepted and ordered placed on file.

COUNCIL COMMITTEE REPORTS

<u>Public Safety – Councilwomen Kuncken/Thistleton</u>

Police, Fire, Ambulance, Court & Violations Bureau, Emergency Management -

Councilwoman Kuncken stated that the Fire Department reports have been brought up to date. The calls for October were as follows: 2 calls, 1 mutual aid, no assists for EMS, 4 drills and 3 special details.

Councilwoman Kuncken reported that the majority of incidents for the Police Department involved moving violations. There were a total of 326 reports.

Councilwoman Kuncken stated that the Ambulance Squad for the month of October had 51 calls, 18 in Stanhope, 31 in Netcong, 2 standbys and 2 out of town calls to Hopatcong. They treated 33 patients for a total of 33 trips to the hospital and travelled 811 miles. The total hours volunteered were 177 hours and 41 minutes.

<u>Finance & Administration – Councilman Benson/Councilwoman Kuncken</u>

Councilman Benson reported that the 2013 year to date collections for water were \$470,949 which is up from \$386,723 from last year. The change in the fee structure is evident. Likewise there is a deduction in the sewer rents. There will be another reduction this year from the MSA. The tax collections were much better this month

<u>Community Development - Councilwoman Zdichocki/Councilman Thornton</u>

Zoning, Construction, Code Enforcement, Economic Development, Chamber of Commerce, Downtown Revitalization – Councilwoman Zdichocki reported that the holiday lighting and decorations will be up during the week of December 2nd.

Councilwoman Zdichocki stated that there were 6 zoning permit applications and there were 9 code violations and complaints.

<u>Municipal Infrastructure – Councilman Thornton/Councilwoman Zdichocki</u>

Water Distribution, Sewer Collection System, Road Construction & Maintenance,
Buildings & Grounds – Councilman Thornton stated that the new fuel pumps were installed last week. Training and distribution of keys will be done next week and some programming took

place yesterday. Administrator McNeilly stated that both systems remained operational to enable a smooth transition.

Information Technology - Councilmen Depew/Benson

Councilman Depew stated that vendors are still being reviewed for a new Borough website. In order to facilitate the change, funds are going to have to be expended. Councilman Depew stated that Administrator McNeilly obtained information at the League of Municipalities meeting that he attended recently. Council President Kuncken stated that Councilman Depew should have that information available during budget discussions.

Boards/Commissions - Councilwoman Thistleton/Councilman Depew

Councilwoman Thistleton stated there were some animal control issues discussed at the last meeting. Councilwoman Thistleton reported that with regard to the stray cats medical care, it is mandatory that they receive all their vaccines and that they be spayed or neutered. Administrator McNeilly stated he will provide the Board of Health with the draft of the Animal Control contract when it is available.

Councilwoman Thistleton stated that the Recreation Commission held a dance last Friday night and it was attended by 117 students. Councilwoman Zdichocki stated there were many parents on hand to help and snacks were provided.

Councilwoman Thistleton stated due to the holiday, garbage collection will be on Friday.

Councilwoman Thistleton stated that the tree lighting and pictures with Santa will be held on December 8th. Councilwoman Zdichocki stated that pictures with Santa and Frosty will take place at Borough Hall two hours prior to the tree lighting. Freeholder George Graham will be assisting with the event.

On motion by Councilman Benson, seconded by Councilman Depew, and unanimously carried by voice vote the Council Committee Reports were accepted.

ADMINISTRATOR'S REPORT

<u>Water Improvement Project</u> – Administrator McNeilly stated that feedback has been received from the County Engineering Department regarding the proposed road closure and detour plan for Brooklyn Road. The comments were minor changes and Mr. Purcell's office has added those changes to the bid specifications. The bid packets have been sent to the printers. The advertising is planned for December 5th or 6th. Bids would then be accepted on January 3rd. Administrator McNeilly stated that due to the anticipated number of bidders and the amount of funds involved, it is recommended that Mr. Stein, Borough Attorney, attend the bid opening. The contracts need to be awarded at the January 14th meeting.

Mr. Stein stated that he spoke with Mr. Purcell earlier today and Mr. Stein will attend the bid opening. As Administrator McNeilly stated, the Borough is under a fairly ridged deadline. The State wants to move the money out into the hands of the contractors to get the money out into the New Jersey economy. The bids will be accepted on January 3rd and Mr. Purcell has indicated that he will be ready by the following Tuesday, which is the reorganization meeting for the Borough. Mr. Stein stated that he will make this a priority and will be ready at that time as well. The resolution should not be adopted as part of the reorganization meeting. Mr. Stein stated that a special meeting can be advertised to be held following the reorganization meeting to award the two contracts. Mr. Purcell is going to speak to the State to determine if he can prepare the packet and deliver it to the State on January 6th or 7th and then forward the resolution to the State on January 15th. If that is not any option then a special meeting will have to be held.

<u>Budget</u> – Administrator McNeilly stated that budget requests have been received from all 16 departments. Budget books are being prepared and Administrator McNeilly requested that the CFO attend the December 10th Work Session to begin the Council review of the budget requests. Council President Kuncken stated that the reorganization preparation is also going to be included in that Work Session.

<u>Property Sale</u> – Administrator McNeilly stated there is a resolution on tonight's agenda to appoint Bob Morgenstern, Dolan and Dolan, as additional conflict counsel for the remainder of

2013. Mr. Morgenstern can then finalize the contract for Weichert Realtors to handle the promotion of the surplus land sale. Mr. Stein stated that the ordinances to authorize the sale of the properties have to be adopted if they have not been done yet. The Governing Body was of the opinion that the ordinances have already been adopted but this will be confirmed.

<u>Animal Control Agreement</u> – Administrator McNeilly stated that a draft of the Animal Control Agreement should be ready for the December 10th meeting.

<u>Reminder</u> – Administrator McNeilly stated that Fire Chief Card will be attending the December $10^{\rm th}$ meeting to discuss the records management system for the Fire Department.

<u>Reorganization Meeting</u> – Administrator McNeilly asked if the Governing Body wants to hold the Reorganization Meeting at the American Legion or at Borough Hall on Tuesday, January 7th. Council President Kuncken suggested that the Fire Department could be an option if the American Legion is not available. Ellen Horak, Borough Clerk, stated that the American Legion will be holding their monthly meeting on January 7th but they have another room at the American Legion that they could use for their meeting if necessary. Council President Kuncken asked the Governing Body for their input. The Governing Body agreed that the American Legion is the first choice and if that is not available a request should be made to the Fire Department.

COUNCIL BUSINESS

<u>Holiday Party</u> – Council President Kuncken asked Ellen Horak, Borough Clerk, for the Holiday Party information which is customarily held in the Borough. Ms. Horak stated that the party would be held on Friday, December 20th at Sal's Pizzeria. Invitations will be distributed soon. Ms. Horak asked for permission to close Borough Hall at 2:00 P.M. on December 20th.

On motion by Councilman Depew, seconded by Councilman Thornton, and unanimously carried by voice vote, approval was granted to close Borough Hall on December 20th at 2:00 P.M. for the Holiday Party.

Mayor & Council Budget - Council President Kuncken stated that the CFO has sent out copies of the budget sheets to all departments, including the Mayor and Council, as we approach the end of the year. Council President Kuncken asked for the Governing Body's comments. Councilman Thornton stated that he was under the impression that the Mayor and Council were over budget for meetings and seminars. Council President Kuncken replied that she is of the opinion that being over budget was what precipitated the conversation about which Council members would be attending the League of Municipalities meeting this year and stated that further clarification is needed. Councilwoman Zdichocki stated that prior to attending the conference in Atlantic City she had stated that in her opinion it is important for the Mayor and Council to attend the conference. At that time, Councilwoman Zdichocki had offered to give up her room in order for another member of the Council to attend because Councilwoman Zdichocki could have used a compensated room. Council President Kuncken asked Mr. Stein if a member of the Council can use a compensated room in a case like this. Mr. Stein stated that would be acceptable in the same way that any member of the Governing Body could pay their own way as well. Councilwoman Zdichocki stated that if more people wish to attend, alternate means should be investigated.

Council President Kuncken stated that the Governing Body needs to make a policy decision to determine if a set number of Council members should attend each year. Administrator McNeilly stated that limitations can be set within the budget process. Councilwoman Thistleton stated there were more meetings at the League Conference that may have provided useful information to the Borough but the three members that did attend could not get to all of the meetings offered. Council President Kuncken stated that during the budget process this issue should be addressed. Council President Kuncken suggested that the reports from those that attended the League of Municipalities be held until the next meeting so that Mayor Maio will be present.

<u>Veteran's Day Program</u> - Councilman Depew stated that he, Councilman Thornton and Councilwoman Zdichocki attended the ceremony on Veteran's Day at the Elementary School. Councilman Depew stated that he was very impressed by the program. It was a nice ceremony and the students were wonderful.

Councilwoman Thistleton stated that she attended the ceremony at the American Legion for Veteran's Day.

<u>Accreditation Program</u> - Council President Kuncken asked Chief Pittigher, present in the audience, if he had any new information regarding the accreditation program. Chief Pittigher stated that the accreditation program is underway. Eight policies have been approved which were not complex. There will be a lot of changes that will be made. Council President Kuncken stated that there will be some expenses incurred in order to meet the requirements. Chief Pittigher stated that additional locks will be needed; locking money bags and different procedures will have to be implemented.

AN ORDINANCE TO AMEND ORDINANCE 2013-15 OF THE BOROUGH OF STANHOPE PROVIDING FOR A SUPPLEMENTAL APPROPRIATION OF \$3,150.00 FOR PRELIMINARY ENGINEERING DESIGN FOR PROPOSED MAPLE TERRACE ROADWAY RECONSTRUCTION AND WATER MAIN REPLACEMENT PROJECT TO BE FULLY FUNDED BY GENERAL CAPITAL IMPROVEMENT FUND

BE IT ORDAINED by the Borough Council of the Borough of Stanhope, in the County of Sussex, State of New Jersey, as follows;

<u>Section 1.</u> Ordinance 2013-15 is hereby amended as follows. The funding for the capital improvement entitled "Preliminary Engineering Design for Proposed Maple Terrace Roadway Reconstruction and Water Main Replacement Project" is hereby amended to include \$3,150.00 from General Capital Improvement Fund, and the total cost of this project is modified to not exceed \$22,800.00, which sum is hereby appropriated for these purposes,

<u>Section 2.</u> The amount of \$3,150.00 for said improvements is hereby to be fully funded from the General Capital Improvement Fund.

Section 3. No additional debt will be authorized by this amendment or for this project.

<u>Section 4.</u> All other provisions of Ordinance 2013-15 unless amended herein shall remain in full force and effect.

<u>Section 5.</u> This ordinance shall take effect ten (10) days after the first publication thereof after final adoption.

Ordinance 2013-18

AN ORDINANCE ESTABLISHING AN ENERGY AGGREGATION PROGRAM PURSUANT TO THE GOVERNMENT ENERGY AGGREGATION ACT OF 2003, N.J.S.A. 48:-93.1 to 98

WHEREAS, the State of New Jersey has been engaged in a process to establish a competitive market place through deregulation and restructuring the electric utility market; and

WHEREAS, the establishment of a government aggregator and an energy aggregation program to purchase electric generation service pursuant to N.J.S.A. 48:3-93.1 et seq. and N.J.A.C. 14:4-6.1 et seq. will increase competition for the provision of electric power to residential and non-residential users, thereby increasing the likelihood of lower electric rates for these users without causing any interruption in service; and

WHEREAS, under the aggregation process the residential and non-residential ratepayers may likely receive a direct reduction in their electric bills; and

WHEREAS, the citizens of the Borough of Stanhope have a substantial economic and social interest at stake; and

WHEREAS, the Governing Body of the Borough of Stanhope hereby finds that it is in the best interests of residential and non-residential electric ratepayers to enter into an aggregation agreement in order to seek substantial savings on electric rates;

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of Stanhope as follows:

- 1. The Borough of Stanhope publicly declares it is a participating member of the Passaic County Energy Cooperative Pricing System per Resolution dated November 26, 2013.
- 2. That the citizens of the Borough of Stanhope desire to participate in the Passaic County Cooperative's Government Energy Aggregation Program and aggregate energy supply service on behalf of its residential and non-residential users of energy pursuant to the Government Energy Act of 2003, N.J.S.A. 48:3-91.3 to -98, and implementing regulations.
- 3. That Passaic County as the Lead Agency will seek bids on behalf of the Cooperative from licensed and appropriate Third Party Suppliers. If such winning bid is selected and agreement executed, individual residential consumers would retain the option not to participate and to choose any alternatives they desire, while non-residential ratepayers would also have the right to participate.
- 4. The Borough Administrator and/or Mayor is authorized to execute and the Borough Clerk to attest to any documents necessary to carry out the purpose of the Ordinance.
- 5. The fully executed agreement shall be kept on file and available for public inspection with the Borough's Clerk's Office.
- 6. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.
- 7. This Ordinance shall become effective immediately upon passage and publication as required by law.

BOROUGH OF STANHOPE RESOLUTION AUTHORIZING THE BOROUGH OF STANHOPE TO ENTER INTO A COOPERATIVE PRICING AGREEMENT KNOWN AS THE PASSAIC COUNTY ENERGY COOPERATIVE PRICING SYSTEM ID#184PCECPS

WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, the County of Passaic, hereinafter referred to as the "Lead Agency " has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services;

ATTORNEY REPORT

Mr. Stein stated that the Governing Body adopted a resolution tonight appointing Mr. Morgenstern as conflict counsel for the remainder of 2013. Mr. Stein stated that Attorney Mark Hontz has informed him that he does not wish to be reappointed as conflict counsel for next year. Mr. Stein stated that when he spoke with Mr. Morgenstern, regarding the current project, Mr. Morgenstern indicated that he is interested in being conflict counsel for 2014. Mr. Morgenstern's partner, Mr. Thomas, is the attorney for the Borough's Land Use Board. Mr.

Stein stated that under the current ethical rules an attorney from the same firm can serve as the Land Use Board attorney and another attorney from that firm can serve as a special counsel to the Governing Body. Mr. Morgenstern would not have any conflict in being appointed as conflict counsel.

Mr. Stein stated that he and Administrator McNeilly will be attending a meeting on December 10th at the County to meet with County Counsel and the County Engineer regarding the quiet zone. County Counsel has a great deal of paperwork from the Federal Government that needs to be addressed. Council President Kuncken asked if Councilwoman Zdichocki or Councilman Thornton should attend. Mr. Stein stated in his opinion it is not necessary at this time. Administrator McNeilly stated that if the Borough gets approval for a quiet zone, it will be the only one in the country that would have a quiet zone on the day it opened. The environmental impact study from Lake Hopatcong to Scranton, PA indicates that 200+ homes will be impacted by noise. 187 of those homes are relative to this crossing. This will only eliminate the sound of the whistle blowing. All other noise reducing requests were denied.

Seeing no one from the public wishing to speak, Council President Kuncken closed the public portion of the meeting.
