When the ACO goes on a call to pick up a cat killed on the road she stores the cat up to 7 days in freezer in case owner inquires about missing cat.

238 Aspen Court - ACO was sent by dispatch to help owner trap cat. Owner complained that the cat was attacking her. ACO explained that this is not a service she provides but dispatch wanted her to go. ACO dropped off trap and picked up trap. Cat was not captured. Owner did have scratches. Discussion took place about owner being responsible for her cat. Discussed in what situation and who would charge pet owner ACO reimbursement fee. Should we send homeowner a ill? Discussion took place about what services people except from the ACO. Dispatch considered it a safety issue.

Could include in contract that Hopatcong notify residence that they will be charged for ACO's time.

Check to see if cat is licensed. Talk to Administrator about sending a summons for unlicensed animal and letter that she will be charged in the future if ACO comes out on for services not in ACO's job description.
