PAULA ZELIFF-MURPHY WILL ATTEND TO ANSWER QUESTIONS. WE
ANTICIPATE A QUESTION ABOUT HOW MUCH EXTRA WORK WILL BE
ADDED TO THE DEPUTY CLERKS RESPONSIBILITIES. PZ TO CHECK HOW
MANY PERMITS WERE ISSUED THE PAST FEW YEARS.

BRIAN MCNEILLY ADVISED US OF A GRANT OPPORTUNITY FROM

MONEY FOR THE HAZARDOUS TREE INVENTORY. PZ TO FILL OUT THE
