BOARDS (2). IN VC'S ABSENCE PZ ASKED MG TO ASK PATTI IF SHE
WOULD ATTACH THE SCREWS TO THE NEW BOARDS.**

**PZ REPORTED ON 2 TREES THAT SHE INSPECTED DUE TO PH^oNE
CALLS FROM HOMEOWNERS. B McNEILLY WAS ADVISED AS TO THE**

CONDITION OF BOTH. THE LAKEVIEW AVE TREE NEEDS ATTENTION, THE TREE ON SPRING LANE WILL PROBABLY BE TAKEN CARE OF BY JCP&L, IT IS DEAD BUT IT IS A SMALL TREE.

WE DISCUSSED THE TREES THAT WERE REMOVED WITHOUT A PERMIT(5 AS FAR AS WE COULD TELL). PZ SUGGESTED A LETTER ADVISING THE HOMEOWNER OF OUR TREE ORD AND INVITING THE OWNER TO OUR NOV 21 PROGRAM.
